CoVid Procedures and Protocol

We will be ready to jump to virtual learning with ALL classes if mandated - all prices will remain fixed, regardless of the need for virtual learning.

For the Dancers (Parents:

Unless mandates determine otherwise, we will hold all classes in person at the studio with the following protocols in place - restrictions are based on state and federal government mandates - any changes in our protocols based on changes in those mandates, will be announced on our Facebook page

For the 2021-2022 Season:

- Dressing rooms are closed please arrive with your dance attire already on you may layer, but all layers that are removed will need to remain in your designated bag space in the dance room
- Please arrive with a small dance bag containing only your dance shoes, water bottle and a pair
 of socks
- All dancers will receive a health screening with our receptionist upon arrival please do not
 attend classes if you have been exposed to Covid 19, or have any symptoms we ask that
 you leave directly following your class(es) please have your ride ready
- All parents are asked to drop their dancer off at the door, and return only when class(es) conclude(s) all the way down to our very youngest students, the dancers did a beautiful job in our 20-21 season with their independence and we are so confident they will continue to do so, with great nurturing care from our staff and faculty who are always available to help
- All dance rooms and capacity limits allow for social distancing while dancing we will continue to exercise great caution in keeping the dancers spaced appropriately
- We will defer to executive orders as they unfold and remain fluid, to determine mask protocol
 while dancing
- The bathroom will be available to use for bathroom needs only the water bottle filler will be available to use - the drinking fountain is closed
- Frequently touched surfaces throughout the studio are wiped down at regular intervals hand sanitizing stations are available in each dance room and in the lobby - concession stand is closed but water will be available for purchase
- Copies of the document outlining our Covid Compliance and Checklist of Operations is available to request via email

What you can expect from us: Glenns' School of Dance will:

- Develop a COVID-19 preparedness and response plan, consistent with recommendations in Guidance on Preparing Workplaces for COVID-19, developed by the Occupational Health and Safety Administration. Within two weeks of resuming in-person activities, a business's or operation's plan must be made readily available to employees, labor unions, and customers, whether via website, internal network, or by hard copy.
- Designate one or more worksite supervisors to implement, monitor, and report on the COVID-19 control strategies developed under subsection (a). The supervisor must remain on-site at all times when employees are present on site. An on-site employee may be designated to perform the supervisory role.
- Training: provide COVID-19 training to employees that covers workplace infection-control practices, proper use of personal protective equipment, steps the employee must take to notify the business or operation of any symptoms of COVID-19 or a suspected or confirmed diagnosis of COVID-19, how to report unsafe working conditions and maintain a record of meeting the training requirement.
- Self-Screening Protocol: conduct a daily entry self-screening protocol for all employees or contractors
 entering the workplace, including, at a minimum, a questionnaire covering symptoms and suspected or
 confirmed exposure to people with possible COVID- 19, and maintain a record of meeting the selfscreening requirement.
- Social Distancing: We will continue to follow all CDC recommendations and/or federal and state governmental mandates adhering to the fluidity of the pandemic
- Face Coverings/Shields and PPE: We will continue to follow all CDC recommendations and/or federal and state governmental mandates adhering to the fluidity of the pandemic
- Cleaning/Disinfection: increase facility cleaning and disinfection to limit exposure to COVID-19, especially on high-touch surfaces (e.g., door handles), paying special attention to parts, products, and shared equipment (e.g., tools, machinery, vehicles), make cleaning supplies available to employees upon entry and at the worksite and provide time for employees to wash hands frequently or to use hand sanitizer, adopt any additional infection-control measures that are reasonable in light of the work performed at the worksite and the rate of infection in the surrounding community, adopt protocols to clean and disinfect the facility in the event of a positive COVID-19 case in the workplace.
- Maintain accurate records, including date and time of event, name of attendee(s), and contact information, to aid with contact tracing.
